◆ Event highlights need for employment options for people with disabilities

Salisbury, Maryland might seem an unlikely place for three Cabinet Secretaries to join forces to promote the need for more job opportunities for people with disabilities. But the Salisbury site—**K&L Microwave**—proved an exemplary backdrop due to the company’s ongoing commitment to hiring individuals with disabilities.

“In Maryland, like many other states, we have an incredibly high unemployment rate for individuals with disabilities,” commented **Secretary Kristen Cox** of the Maryland Department of Disabilities. “Companies like **K&L Microwave** are the model. We hope other Maryland businesses step up and provide opportunities to people with disabilities so they can prove they can do the job.”

Secretary Cox was joined by **Secretary Aris Melissaratos** of the Maryland Department of Business and Economic Development and **Secretary James D. Fielder, Jr., Ph.D.**, of the Maryland Department of Labor, Licensing and Regulation, along with other leaders from state government and non-profit agencies. During the August 17 event, agency heads and guests toured the plant and observed K&L employees successfully working in competitive, integrated jobs.

K&L employee **Louis Gentile**, who measures ceramic resonators at the plant, demonstrated how his obsessive attention to detail makes him the perfect employee for a job where the margin of error is two-thousandths of an inch.

“Our company focuses on the individual’s abilities and looks for a position that will be a good match,” said **Robin Hall**, Human Resource Manager at K&L Microwave, a Dover Company. “We’ve had a lot of success approaching hiring this way — concentrating on what people can do, not what they can’t do.”

◆ Gov. Ehrlich Offers Maryland Relay Services to Katrina Victims

Maryland Relay and its service provider, **AT&T**, have agreed to offer assistance to individuals with communications disabilities in states hit by Hurricane Katrina, where Relay Centers have been destroyed or rendered inoperable due to power outages and structural damage.

Maryland operators will help process calls made to and from Katrina-stricken states that would normally be processed through centers located in Louisiana, Alabama and Mississippi. Users can place calls to the same telephone numbers; however, the calls will be routed through Maryland or other states helping with this effort.

Maryland operators may be handling hundreds of additional calls, so Maryland users are asked to be patient if calls are not answered as quickly as usual. This situation is temporary until Relay Systems in Louisiana, Alabama and Mississippi have been restored.
